Commission applications are due by 1 pm the Monday before a regularly scheduled IWC meeting, which are typically the 3rd Thursday of every month at 7:00 pm. Please note, applications for activity within a one (1) mile from the shore of Lake Waramaug will be subject to a 3rd party engineering review, at the applicant's cost, based on the level of the proposed impact to the wetlands and/or watercourses associated with this application. Applicants should be aware of this prior to submitting the application materials and are strongly urged to discuss with the wetland's agent prior to planning and submission.

A request to extend the deadline of a wetlands license must be submitted to the Town's Inland Wetlands & Conservation Commission and must be formally approved via this application process.

☐ **POST-WORK APPROVAL** \$230.00
If work that has not been authorized is conducted in the wetlands and/or watercourse or within the Regulated Area, the property owner and/or its agent will have to come before the Commission for an after-the-fact permit and/or restore the impact to the wetlands and/or watercourses.
